



Tuition and Fees

Registration Fee: \$100 non-refundable registration fee is due with registration.

Tuition: Tuition is an annual fee divided into 10 equal monthly payments.

The first month's tuition is due June 1, or within 15 days of the date on your letter of acceptance to MCP, if accepted after June 1.

September – May tuition is due on the 1st of each month. A \$20 late fee will be charged for tuition payments received in the office after the 10th of each month.

You may also choose to pay annual tuition in one lump sum. If paid on or before June 1, you will realize a 3% discount.

Materials Fee: The materials fee helps to cover the cost of consumable supplies and other materials for the children. The materials fee is due June 1, or within 15 days of the date on your letter of acceptance to MCP, if accepted after June 1.

Financial Obligations

I understand that this contract cannot be considered complete without the registration fee (\$100.00 per student, with the exception of VPK only students).

I understand that in order to withdraw my child from MCP, I must give two weeks written notice, and I will still be responsible to pay the tuition for the current month as well as the next month. In addition, a letter will be sent to those families whose tuition is in arrears after 30 days stating that all past due tuition, late charges and current month's tuition will be due within 30 days. If an account becomes 60 days delinquent, the school reserves the right to dismiss the student from school. A \$25 fee will be charged for returned checks.

Maitland Community Preschool reserves the right to refuse any application or dismiss any student, at any time, for any reason. Neither this contract nor payment of fees is considered to be binding upon Maitland Community Preschool.

I understand that the registration and materials fees, as well as the first month's tuition payment, are all non-refundable and non-transferable. Should I withdraw my child from Maitland Community Preschool for any reason, none of these fees will be refunded and I will be responsible to pay the tuition as described above.

VPK families: I understand that I am responsible for any tuition not reimbursed by the state for VPK hours.

 Monthly Total tuition will be paid in 10 monthly payments, August tuition being paid by June 1 or within 15 days of the date on your letter of acceptance; September – May due on the 1st of each month.

 Annually Total tuition will be paid in one payment, including a 3% discount if paid by June 1.
